Subject: Meeting regarding extension of non-binding MoU between BWDB and POWERCHINA

A discussion meeting will be held on 12/01/2025, 3.30 pm at the conference room of the Hon'ble Director General (Level: 5, Room No: 507) regarding the extension of a non-binding MoU between the Bangladesh Water Development Board (BWDB) and Power Construction Corporation of China (POWERCHINA) related to the 'Sustainable River Management Project' in Bangladesh'. The MoU was initially signed on September 28, 2016, for a validity period of three years. Under this MoU, POWERCHINA was responsible for preparing the Master Plan, conducting feasibility studies, reviewing existing reports and data, completing detailed designs, and implementing the priority project, including securing financing. To ensure the completion of the pending tasks, the MoU has been extended three times to date.

Currently, POWERCHINA has submitted the enriched Feasibility Study Report to BWDB and has applied for a fourth time extension, requesting an additional two years (up to September 28, 2026) to complete other engineering and remaining pending works under the MoU.

The meeting will be chaired by the Hon'ble Director General, BWDB.All officers mentioned in the distribution list are requested to attend the meeting on time.
