WHEREAS the Procuring Entity invited Tenders for certain works, viz, Protective Work Along the L/B of Arial Khan River from Km 19.000 to Km 21.800 = 2.800 Km at Sannasir Char Union, L/B of Arial Khan River from Km 30.700 to Km 31.700 = 1.000 Km at Boheratala Union & R/B of Arial Khan River from Km 32.300 to Km 34.800 = 2.500 Km at Siruail & Nilokkhi Union Grand Total PW Length = 6.300 Km & Dredging of Arial Khan River from km 19.100 to Km 21.800 = 2.700 Km & Km 23.800 to Km 35.000 = 11.200 Km & Intake Channel of Utrailhat Baor from Km 0.000 to Km 0.850 = 0.850 Km Grand Total DW Length = 14.750 Km in Connection with "Bank Protective Work & Dredging in Arial Khan River at Shibchar Upazila of Madaripur District" Under Madaripur O&M Division, BWDB, Madaripur during the FY 2020-21 & 2021-22 & 2022-23 (Package: Arial Khan/Madaripur/DPM-48) and has accepted a Tender by the Contractor for the execution of those works in the sum of Taka 367,28,48,950.88 (Three Hundred Sixty-Seven Crore Twenty-Eight Lakh Forty-Eight Thousand Nine Hundred And Fifty Point Eight Eight) (hereinafter called “the Contract Price”).

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:
