The Consultancy Firm shall not, during the term of this contract and within two years after its expiration, disclose any proprietary or confidential information relating to the services, this contract or the Client's business or operation without the prior written consent of the client.

Ownership of materials

Any study reports or other material, graphic, software or otherwise, prepared by the Consultancy Firm for the client under the contract shall belong to and remain the property of the Client. The Consultancy Firm may retain a copy of such documents.

9.

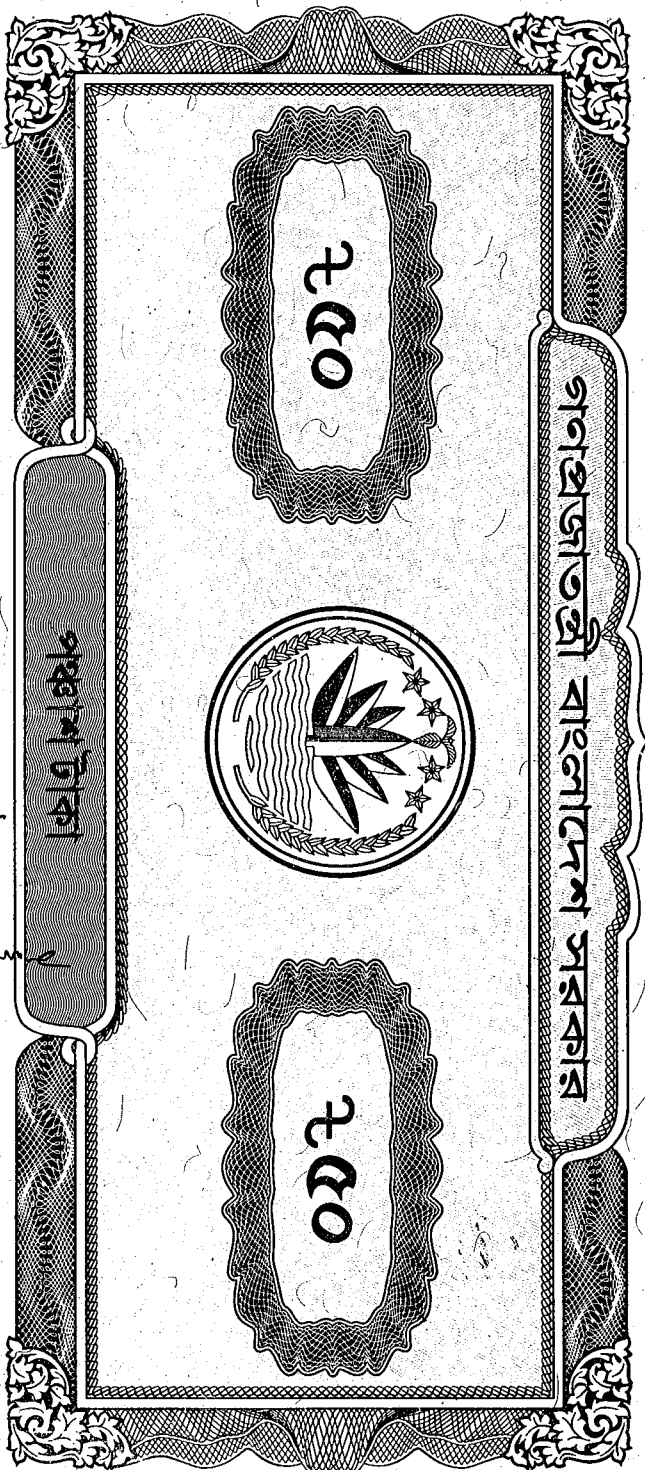
Variations

When the severity of Covid-19 and the pandemic situation is very minor or almost gone then the medical Center will be turned into general medical center instead of covid dedicated medical center. Then the client shall review the Contract, Employee Remuneration, No. of Manpower and any part of the GCC, PCC as deem fit.

The contract shall be governed by the laws of Bangladesh, and the language of the Contract shall be English and Bangla as and where applicable.

12. Termination

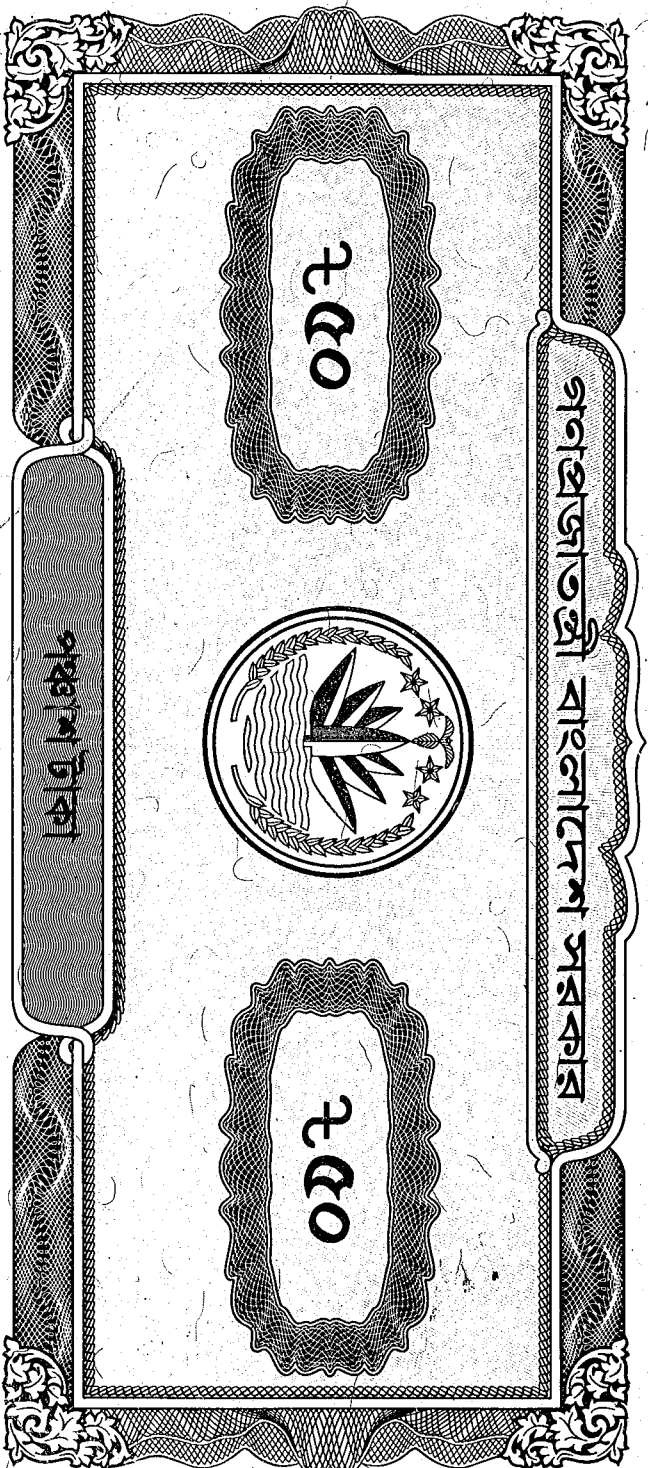
Termination of contract might be accompanied by rules mentioned in the GCC and other clauses of the contract agreement.

Any notice under this contract shall be in the form of letter or fax. Notice to either party shall be given at such address, as such party shall be properly addressed to:

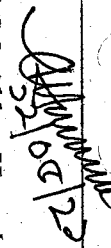
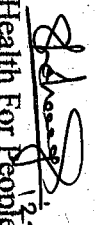
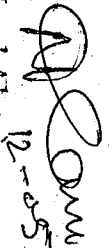
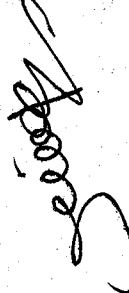
